Memorandum To:

Mayor McClellan called the meeting to order at 3:15 P.M., noting the absence of Councilmembers Mullen, Goodman, and Urdy.

Motion

The Council, on Councilmember Duncan's Motion, Councilmember Deuser's Second, adopted a resolution canvassing returns and declaring the result of a bond election held in Austin, Texas on the 15th day of January, 1983, with the following votes cast: (4-0 Vote, Councilmembers Goodman, Mullen, and Urdy absent)

PROPOSITION NUMBER 1

"THE ISSUANCE OF \$97,000,000 REVENUE BONDS FOR ELECTRIC LIGHT AND POWER SYSTEM EXTENSIONS AND IMPROVEMENTS (CONTINUED FINANCING THROUGH MARCH, 1984, OF THE CITY'S PARTICIPATION IN THE SOUTH TEXAS PROJECT TO AVOID LEGAL COMPLICATIONS AND TO PROTECT THE CITY'S FINANCIAL INTEREST, INCLUDING THE RIGHT TO SELL ITS INTEREST THEREIN)

AGAINST	4,543 votes
TOTAL VOTES CAST	19,057 votes
