Authorize award and execution of a 24-month requirements supply agreement with MUELLER SYSTEMS, LLC, for repair parts for Hersey water meters for the Austin Water Utility in an amount not to exceed \$288,000.

Amount and Source of Funding

Funding in the amount of \$96,000 is available in the Fiscal Year 2011-2012 Operating Budget of the Austin Water Utility. Funding for the remaining sixteen months of the original contract period is contingent upon available funding in future budgets.

This contract establishes an annual agreement for the supply of repair parts for Herseywater meters for the Austin Water Utility (AWU). Repair parts will be purchased on an as needed basis and will be stored at the Water Meter Shop. Hersey meters, three inches and above, are accuracy tested in the field. If the meter fails its accuracytest, it is repaired in the field with newparts and retested to insure accuracy. These parts are necessary for that process.
