ORDINANCE NO.
AN ORDINANCE AMENDING ORDINANCE
NO. 20100527-047 RENEWING A FRANCHISE
TO AUSTIN CAB I, INCORPORATED,
D/B/A AUSTIN CAB TO ALLOW FOR THE AL-
LOCATION OF 15 ADDITIONAL TAXICAB
PERMITS.
BE IT ORDAINED BY THE CITY COUNCIL OF
THE CITY OF AUSTIN:
PART 1. Part 3 of Ordinance No.
20100527-047, which renews a franchise to
Austin Cab I, Incorporated, d/b/a Austin Cab
to operate a taxicab service in the City of Aus-
tin, is amended to read:
PART 3. FLEET SIZE.
The franchise holder must maintain an active
fleet of at least 25 and not more than 177
taxicabs. This taxicab allocation may be
amended during the course of the franchise.
PART 2. The franchise holder shall file its writ-
ten acceptance of the terms of this amend-
ment to its franchise ordinance, Ordinance
No. 20100527-047, with the City Clerk no later
than May 18, 2012.
PART 3. This ordinance becomes effective on
May 21, 2012, unless the franchise holder fails
to file its written acceptance of this ordinance
as required by Part 2. If the franchise holder
fails to file its written acceptance, this ordi-
nance is void.
** Note: Above is the full text of the sec-
ond reading of an ordinance under Austin
City Council consideration. This ordinance
is not final and is subject to change. There
will be one future reading of this ordi-
nance before the Austin City Council may
approve it.


