CALL TO ORDER

1. CITIZEN COMMUNICATION

Joy Casnovsky – wanted the board to know she is available to Chair the Healthy/Local food in City/County venues working group.

2. APPROVAL OF MINUTES OF NOVEMBER 28, 2011 AND THE EXECUTIVE COMMITTEE MEETING OF NOVEMBER 21, 2011.

Discussions to revise minutes to item 3A by removing last sentence; change in SHACKs should be SHACs; only one letter was presented to the planning commission and the drought letter was presented to council. Member Michele Murphy-Smith made a motion to accept the minutes with discussed revisions to the November 28, 2011 minutes. Member Ronda Rutledge seconded motion. Motion passed 9-0-0.

Since a quorum of the executive committee was present, Member Paige proposed that the committee review their minutes. The board agreed unanimously. Member Erin Flynn made a motion to accept the executive committee meeting of November 21, 2011. Member Ronda Rutledge seconded motion. Motion passed 3-0-0 (quorum from executive committee members).

3. CHANGES TO SUSTAINABLE FOOD POLICY BOARD (PAULA MCDERMOTT)

Chair Paula presented the new board member, Adam King, who is Shirene Garcia's replacement. Introduction of Robert Kingham, the new City of Austin Liaison, who is replacing Stephnie Connell. The board members gave a brief description of themselves to the new board member and the liaison.

4. CITY OF AUSTIN RECOMMENDATIONS REGARDING THE U.S. 2012 FARM BILL (ANDREW MOORE – POLICY AIDE TO COUNCIL MEMBER MARTINEZ)

Chair Paula mentioned that the mayor will send out a letter to support federal nutrition, food programs, community gardens and local agriculture. No action taken.

Michele presented the report, only change is 2010 should read 2011. The report is from March of 2010 to 2011. Member Erin proposed a working group to prepare newest SFPB annual report from March 2011- February 2012. Member Toni seconded motion. Motion passed 9-0-0.

- SNAP Working Group Update and Possible Recommendations (Kathy Green) Member Kathy gave an update on the Supplemental Nutrition Assistance Program (SNAP). No action taken.
- **Proposed Buy Local Working Group (Marla Camp)** Item tabled until January 2012 meeting
- Identify Work Plan for Coming Year Board Priorities/Objectives/Working Groups Board is to look at model and give feedback to liaisons

Member Ronda made motion to approve these as the goals and the structure on all three areas. Member Erin seconded motion. Motion passed 9-0-0.
