

## AUSTIN CITYCOUNCIL MINUTES

WORK SESSION MEETING TUESDAY, FEBRUARY 28, 2012

The City Council of Austin, Texas convened in a Special Called Meeting on Tuesday, February 28, 2012, City Hall at 301 W. Second Street, Austin, Texas.

Mayor Leffingwell called the meeting to order at 9:05 a.m.

Mayor Leffingwell recessed the Work Session to go into Executive Session at 9:11 a.m.

The City Council went into Executive Session, pursuant to Chapter 551 of the Texas Government Code, to receive advice from Legal Counsel, to discuss matters of land acquisition, litigation, and personnel matters as specifically listed on this agenda and to receive advice from Legal Counsel regarding any other item on this agenda
