Authorize award and execution of a 36-month requirements service contract with PINNACLE PEAK HOLDING CORPORATION DBA SETCOM CORPORATION, to provide repair services for headset equipment used by public safety personnel for the Communications and Technology Management, Wireless Communication Services Division in an estimated amount not to exceed \$60,000 with three 12-month extension options in an estimated amount not to exceed \$20,000 per option, for a total estimated contract amount not to exceed \$120,000.

Amount and Source of Funding

Funding in the amount of \$10,000 is available in the Fiscal Year 2011-2012 General Fund Radio Maintenance Budget. Funding for the remaining 30 months of the original contract period and the extension options is contingent upon available funding in future budgets.

Fiscal Note

There is no unanticipated fiscal impact. A fiscal note is not required.

Additional Backup Information

This contract provides the Wireless Communications Services Division (WCSD) with factory-level repair services for Setcom equipment that is beyond the scope provided by the Wireless Communication Services Division. This service is required to ensure that these critical communication systems function optimally.

WCSD provides repair services for both internal and external Public Safety customers, including the Emergency Medical Department, Austin Police Department, and Travis County Sheriff's Office.

The City is reimbursed through established service agreements for repairs provided to external customers.

The Setcom wireless systems enable the Austin Police Department Motorcycle Traffic Officers, Travis County Motorcycle Traffic Officers, and Emergency Medical Department First Responder Personnel to provide on-site communication to command vehicles, dispatch centers, and other emergency vehicles.
