Authorize award and execution of a 36-month requirements supply agreement with OSBURN ASSOCIATES, INC., for pre-fabricated traffic signs for the Transportation Department in an estimated amount not to exceed \$755,622 with two 12-month extension options in an estimated amount not to exceed \$251,874 for each option, for a total estimated contract amount not to exceed \$1,259,370.

## Amount and Source of Funding

Funding in the amount of \$146,927 is available in the Fiscal Year 2011-2012 Operating Budget of the Transportation Department. Funding for the remaining 23 months of the original contract period and for the extension options is contingent upon available funding in future budgets.

## Additional Backup Information

This contract is for the purchase of prefabricated traffic signs to be used to replace old and missing traffic signs city wide. The useful life of a traffic sign is approximately ten years. Traffic signs maintenance is important as a means of reducing day and nighttime crash rates. Signs that have sufficient retro reflectivity during nighttime conditions are especially beneficial to older road users. Safe and efficient highways are a benefit to the motoring public and the health and viability of a community. In addition, the Manual of Uniform Traffic Control Devices (MUTCD) now requires that agencies maintain traffic signs to a set of minimum levels.
