

AUSTIN CITYCOUNCIL MINUTES

WORK SESSION MEETING TUESDAY, MARCH 27,2012

The City Council of Austin, Texas convened in a Special Called Meeting on Tuesday, March 27, 2012, City Hall at 301 W. Second Street, Austin, Texas.

Mayor Pro Tem Cole called the meeting to order at 2:10 p.m. Mayor Leffingwell was absent.
