#### **MINUTES**

#### CALL TO ORDER - Vice-Chair Woodroffe called the meeting to order at 6:12 p.m.

#### A. CITIZEN COMMUNICATIONS

#### B. APPROVAL OF MINUTES

#### C. NEW BUSINESS

1. Hear presentation and take appropriate action on a request for variance from LDC Section 25-2-738(E) (*North Shore Central Subdistrict Regulations*) for the proposed Central Library - Lake/Flato Architects

Vote was taken 3 - 2 to recommend approval of variance with a motion by Mr. Pilgrim and second by Mr. Rindy (Pilgrim, Rindy and Woodroffe approval and Mann and Walton dissenting). The vote was not valid because four (4) affirmative votes are required for an action to be considered effective.

- 3. Discussion and possible action regarding election of Acting Chair and Acting Vice-Chair. Daniel Woodroffe was elected to Acting Chair by a unanimous 5-0 vote, with a motion by Mr. Mann and second by Mr. Walton. Brooke Bailey was elected to Acting Vice-Chair by a unanimous 5-0 vote with a motion by Mr. Walton and second by Mr. Mann.
- 4. Appoint member to vacant position on Design Criteria and Bonus Provision Committee. **Dean Rindy was appointed by Acting Chair Woodroffe.**
- 5. Annual reports from the Design and Development Framework Committee and the Design Criteria and Bonus Provision Committee.
