NO. 20070517-064 ÄWARDING A FRANCHISE TO LONE STÂR CAB COMPANY TO
ALLOW FOR 30 ADDITIONAL TÂXICAB
PERMITS, AND TO DELETE PART 4 RELATING TO TÂXICAB FRANCHISE OWNER REQUIREMENTS.
BE IT ORDAINED BY THE CITY COUNCIL OF
THE CITY OF AUSTIN:
PART 1. Part 3 of Ordinance No.
20070517-064, which awards a franchise to
Lone Star Cab Company, is amended to read:
PART 3. FLEET SIZE.
The franchise holder must maintain an active
fleet of at least 25 and not more than 88 taxicabs. This taxicab allocation may be
amended during the course of the franchise.
PART 2. Part 4 of Ordinance No.
20070517-064 is deleted.
PART 3. Lone Star Cab Company will receive
no additional taxicab permits under City Code
Sections 13-2-322 (Calculation of Necessary
Franchise Permits), 13-2-324 (Allocation of
Additional Franchise Permits), or 13-2-327
(Distribution of Additional Permits), otherwise known and "the formula," for the remainder of 2012.
PART 4. The franchise holder shall file its written acceptance of the terms of this amendment to its franchise ordinance, Ordinance
