## Subject

Authorize award and execution of a 24-month requirements supply agreement with AOC WELDING SUPPLY, for liquid sulfur dioxide for the Austin Water Utility in an estimated amount not to exceed \$338,800, with two 12-month month extension options in an estimated amount not to exceed \$169,400 per extension option, for a total estimated contract amount not to exceed \$677,600.

## Amount and Source of Funding

Funding in the amount of \$56,467 is available in the Fiscal Year 2011-2012 Operating Budget of the Austin Water Utility Department. Funding for the remaining twenty months of the original contract period and extension options is contingent upon available funding in future budgets.

# Additional Backup Information

This contract establishes an annual agreement for the supplyof Liquid Sulfur Dioxide for the Austin Water Utility (AWU). Liquid Sulfur Dioxide is used at the wastewater treatment plants to treat the chlorinated wastewater prior to release. Sulfur dioxide reduces free and combined chlorine to chloride. This reduction prior to release is required by the Texas Commission on Environmental Quality.
