A Substantial Amendment to the City's Fiscal Year 2011-2012 Action Plan and Community Development 2011-2012 Program is adopted as shown on the attached Exhibit A which is incorporated by reference.

**BE IT FURTHER RESOLVED:**


This Substantial Amendment will allow the City of Austin to administer additional grant funds made available to the City of Austin from the Emergency Solutions Grant program funds authorized by the Steward B. McKinney Homeless Assistance Act of 1987, as amended by the Homeless Emergency Assistance and Rapid Transition to Housing Act of 2009 (HEARTH Act).

**BE IT FURTHER RESOLVED:**

The Emergency Solutions Grant program funds (\$185,896) will be disbursed as follows:

- \$132,218 for the ESG Rapid Rehousing Program in the category of Rapid Re-housing – Housing Relocation and Stabilization Services for homeless individuals who are frequent users of public systems including the Downtown Austin Community Court and Austin Resource Center for the Homeless.
- \$31,472 for expenses related to the Homeless Management Information System (HMIS) for the Austin Resource Center for the Homeless and Downtown Austin Community Court to comply with increased ESG requirements and coordinate services for the ESG Rapid Rehousing program.
- \$22,206 for Administration of the new funding. The new allocation allows grantees to request funds for up to 7.5% of the total 2011-2013 allocation.

## **SUBSTANTIAL AMENDMENT TO THE FISCAL YEAR 2011-12 ACTION PLAN EMERGENCY SOLUTIONS GRANT ALLOCATION SUMMARY**

On December 1, 2011, the Department of Housing and Urban Development (HUD) notified cities that receive Emergency Shelter Grant (ESG) program funds about the eligibility to receive additional FY 2011-12 ESG funds to carry out the new activities. This second allocation is the Emergency Solutions Grants (ESG) program funding, which will replace the Emergency Shelter Grant. The City of Austin plans to apply for \$185,896 in additional grant funds made available to through HUD's Emergency Solutions Grant program funds authorized by the Steward B. McKinney Homeless Assistance Act of 1987, as amended by the Homeless Emergency Assistance and Rapid Transition to Housing Act of 2009 (HEARTH Act). In order to apply and to receive these funds, the City of Austin must amend the current FY 2011-12 Action Plan.

HUD Guidelines from ESG presentations:

- "HUD strongly encourages jurisdictions to target new funds toward assisting individuals living on the streets or emergency shelters."
- "Effective Rapid Rehousing can transition people out of homelessness quickly and decrease the overall number of people that are homeless in the community."
- "Rapid Rehousing should be given highest priority under ESG to ensure that existing resources – within and outside the homeless assistance system- are used as efficiently as possible."

### **City of Austin Allocation for Emergency Solutions Grant**

Of the \$185,896 newly allocated for the Emergency Solutions Grant, the City of Austin will allocate all funds in compliance with program guidelines released through the U.S. Department of Housing and Urban Development (HUD):

- \$132,218 for the ESG Rapid Rehousing Program in the category of Rapid Rehousing – Housing Relocation and Stabilization Services for homeless individuals who are frequent users of public systems including the Downtown Austin Community Court and Austin Resource Center for the Homeless.
- \$31,472 for expenses related to the Homeless Management Information System (HMIS) for the Austin Resource Center for the Homeless and Downtown Austin Community Court to comply with increased ESG requirements and coordinate services for the ESG Rapid Rehousing program.
- \$22,206 for Administration of the new funding. The new allocation allows grantees to request funds for up to 7.5% of the total 2011-2013 allocation.

### **City of Austin Program Objectives for new Emergency Solutions Grant funding:**

- Shift Shelter services from short-term recurrent interventions to long-term housing solutions.
- Create coordinated shelter intake system in HMIS between FrontSteps Arch and Salvation Army Pathways contracts and implement a scan card system.
- Implement funding with full transparency and achievement of stated outcomes and benefits.

### **City of Austin ESG Rapid Rehousing Program:**

The City of Austin is expected to submit documentation regarding the Substantial Amendment for Emergency Solutions Grant program funding to HUD no later than May 14, 2012. The City of Austin's ESG Rapid Rehousing programs will have one primary goal, to rapidly re-house individuals experiencing homelessness from the downtown service providers as quickly as possible. Federal assistance focuses on housing stabilization; linking program participants to community resources and mainstream benefits; and developing a plan for preventing future housing instability. It is not intended to provide long-term support.

Federally eligible services include financial assistance, housing relocation and stabilization, and data collection. The program plan will include staff located at the Downtown Austin Community Court including an ESG Rapid Rehousing specialist/case worker for outreach, intake and housing related case management; and a housing locator to find apartments and work with landlords; mediation between landlords and tenants; and data management.
