AN ORDINANCE AMENDING ORDINANCE
NO. 20070517-064 AWARDING A FRANCHISE TO LONE STAR CAB COMPANY TO
ALLOW FOR 30 ADDITIONAL TAXICAB
PERMITS, AND TO DELETE PART 4 RELATING TO TAXICAB FRANCHISE OWNER REQUIREMENTS.
'BE IT ORDAINED BY THE CITY COUNCIL OF
THE CITY OF AUSTIN:
PART 1. FINDINGS. The City Charter requires
that a franchise ordinance be published in a
newspaper within five days of each reading of
an ordinance. On April 5, 2012, Council
I adopted Ordinance No. 20120405-041 on
third reading, approving a taxi cab franchise

Adupted Ordinance No. 2012/04/37/41 Ordinance No. 2012/04/37/41 Ordinance for Lone Star Cab Company. The ordinance was not published within five days of ordinance approval. Therefore, Council is required to repeat third reading of this ordi-

nance.
PART 2. Part 3 of Ordinance No.
20070517-064, which awards a franchise to
Lone Star Cab Company, is amended to read:
PART 3. FLEET SIZE.
The franchise holder must maintain an active

fleet of at least 25 and not more than 88 taxicabs. This taxicab allocation may be amended during the course of the franchise.

PART 3. Part 4 of Ordinance No

20070517-064 is deleted
PART 4. Lone Star Cab Company will receive no additional taxicab permits under City Code Sections 13-2-322 (Calculation of Necessary Franchise Permits), 13-2-324 (Allocation of Additional Franchise Permits), or 13-2-327 (Distribution of Additional Permits), other-

wise known and "the formula," for the remainder of 2012.

PART 5. The franchise holder shall file its written acceptance of the terms of this amendment to its franchise ordinance, Ordinance No. 20070517-064, with the City Clerk no later than June 22, 2012

PART 6. This ordinance becomes effective on June 26, 2012, unless the franchise holder fails to file its written acceptance of this ordinance as required by Part 5. If the franchise holder fails to file its written acceptance, this ordi-

nance is void.

PART 7 This ordinance supersedes Ordinance No. 20120405-041
