Committee Recommendation: Replace French doors with a replica window to match the other window on the façade. Do not install shutters. Provide existing elevations or photographs to indicate changes to windows on side elevations.

Reuse existing siding to greatest extent possible, replace with like material on first level as needed, and use wider dimension siding on addition with a trim separation.

Staff Recommendation: Approve the Certificate of Appropriateness as presented, except request that the relocated chimney be constructed in a similar manner to the original chimney.

Remove the stone veneer, but if the veneer is kept, maintain the planter, remove paint, seal the joint between the veneer and the wall, and install gutters. Defer to neighborhood association regarding roofing material.

Staff Recommendation: Approve the Certificate of Appropriateness as presented, but recommend replacement windows be non-clad, wood sashes.
