Authorize execution of a construction contract with MCLEAN CONSTRUCTION INC., for the Group 19 Phase 1 Street Reconstruction and Utility Adjustments Project, a 2010 Bond Program and ACCELERATE AUSTIN PROJECT, in the amount of \$4,383,999.50 plus a \$219,199.97 contingency, for a total contract amount not to exceed \$4,603,199.47.

Amount and Source of Funding

Funding in the amount of \$2,740,719.55 is available in the Fiscal Year 2011-2012 Capital Budget of the Public Works Department. Funding in the amount of \$1,862,479.92 is available in the Fiscal Year 2011-2012 Capital Budget of the Austin Water Utility.

Additional Backup Information	

This ACCELERATE AUSTIN project is located on Parkwood Road, Norwood Road, Elwood Road, Bentwood Road, Fairwood Road, Fernwood Road, Rowood Road, and Service Way in east Austin. The work includes replacement of a pressure reducing valve, 7,000 linear feet of water line, 3,160 linear feet of wastewater line and 2,670 linear feet of storm drain line and box culvert, as well as full depth street reconstruction or milling and overlaying of the streets. Replacement of some driveways and curb and gutter is also included. Work is scheduled to begin in June 2012 with an estimated completion date of January 2013. Two neighborhood associations were contacted and updated on the project.

Due to the potential for unknown subsurface conditions and utility conflicts when working in the right of way, a 5% contingency has been included to allow for the expeditious processing of any change orders.

The contract allows 320 working days for completion of this project. This project is located within zip code 78722 and is managed by the Public Works Department.
