**Summary of Complaint** Caller stated that Home Slice Pizza had loud music and wanted someone to go out there with a sound meter. Caller stated that they would wait for officers to arrive. No other call information provided.

**Results:** During the period of April 12, 2011 through April 12, 2012, there was 1 disorderly conducts call for service at 1415 South Congress Avenue.
