Authorize award and execution of a 36-month requirements service contract with YOSAN, INC. dba INTERNATIONAL BUILDING SERVICES, or one of the other qualified bidders for IFB-BV No. PAX0217, to provide window cleaning services for various City Departments at various City locations, in an estimated amount not to exceed \$325,780, with three 12-month extension options in estimated amounts not to exceed \$154,656 for the first extension option, \$185,587 for the second extension option, and \$222,705 for the third extension option, for a total estimated contract amount not to exceed \$888,728.

Amount and Source of Funding

Funding in the amount of \$22,375 is available in the Fiscal Year 2011-2012 Operating Budget of various City Departments. Funding for the remaining 32 months of the original contract period and extension options is contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

	Additional Backup Information

This contract will provide interior and exterior window cleaning services, on an as-need basis, for City owned facilities of the Aviation Department, Building Services Department, Library Department, Police Department, Fire Department, and Convention Center Department. Yosan Inc. will provide the necessary staging, equipment, supplies, and personnel to perform the required services. The services provided under this agreement will comply with all applicable City of Austin guidelines, as they relate to cleaning and safety.

This request allows for the execution of a contract with a bidder, who provides the best value to the City, that Council selects. If this bidder does not execute a contract with the City, staff will return to Council so that Council may select another best-value bidder and authorize a contract with this bidder.

In order to determine the best value to the City, evaluation criteria included labor rate, cost of material, cost of equipment rental, and sustainability.
