ANALYSIS / ADDITIONAL INFORMATION: This project is part of the 2006 Bond Street Reconstruction Program. This project is located on 8th Street, beginning at West Avenue and ending at Congress Avenue. The work includes full depth reconstruction of the road, storm drainage improvements, streetscape improvements including planting and benches, approximately 4,800 linear feet of various sizes of water line, 6 fire hydrants, 1,570 linear feet of 6-and 8-inch wastewater line, and sidewalk repair where required. This project is scheduled to begin in June of 2012 and be substantially complete in November of 2014. The project team has communicated with residents and business owners in the affected areas through a combination of emails, postal mailings and website updates.

Due to the potential for unknown subsurface conditions and utility conflicts when working in the right of way, a 5% contingency has been included to allow for the expeditious processing of any change orders.

This contract allows 540 calendar days for substantial completion of this project. This project is located within zip code 78701 and is managed by the Public Works Department.
