That the City of Austin, a municipal corporation, acting by and through its City Manager or Deputy City Manager, hereunto duly authorized, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable cash consideration to it in hand paid by Perseo, Inc., a Texas Corporation, the receipt in hand of which is hereby acknowledged, has GRANTED, SOLD, CONVEYED and CONFIRMED unto the said Perseo, Inc., a Texas Corporation, of Austin, Travis County, Texas, all the following described real property, the premises, to wit:

All that certain tract, piece or parcel of land lying and being situated in the County of Travis, State of Texas, described in EXHIBITS "A" and "B" attached hereto and made a part hereof for all purposes, to which reference is here made for a more particular description of said property vacated by the City Council on April 21, 1983 by Ordinance No. 830421-Q.

Subject however, to the following conditions which shall be rights reserved and covenants running with the land:

1. There shall be no credit allowed for the above vacated street area as to zoning density.
2. The density of beneficiary properties is limited to forty (40) units per acre.
3. The entire above described street area is hereby reserved and retained as an easement for public utilities.
4. Lots 8 through 11 abutting the vacated area shall be developed only as one tract.

TO HAVE AND TO HOLD the said described real property, the premises, together with all and singular the rights and appurtenances thereto in anywise belonging unto the said Perseo, Inc., a Texas Corporation, its successors and assigns forever; and the City of Austin does hereby bind itself, its successors and assigns, to Warrant and Forever Defend all and singular the said premises unto the said Perseo, Inc., its successors and assigns, against every person whomsoever lawfully claiming or to claim the same or any part thereof, by, through, or under the City of Austin, but not otherwise.

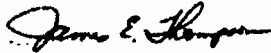
FIELD NOTES FOR 12,000 SQUARE FEET OF LAND, SAME BEING

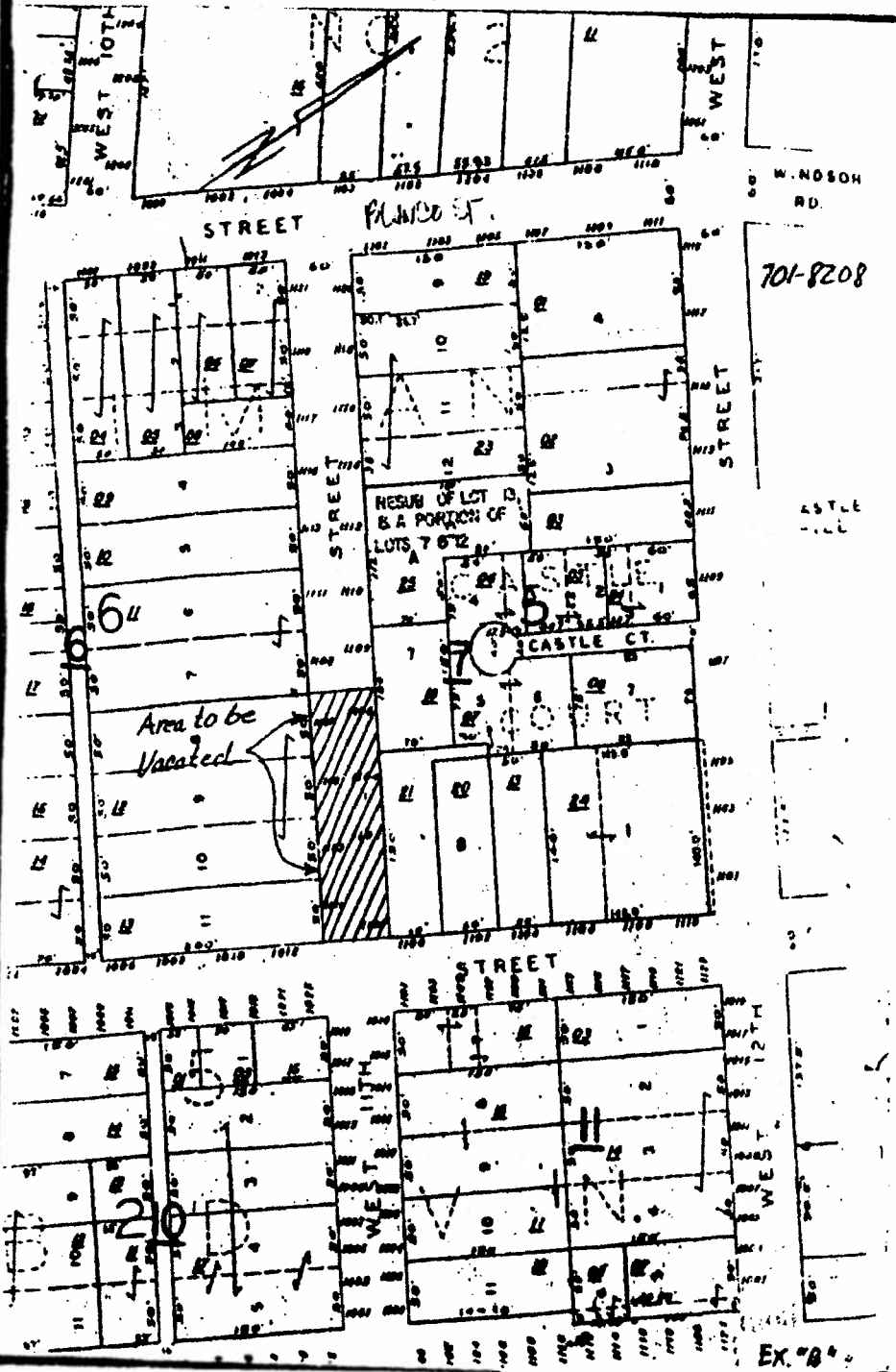
