Additional Backup Information					

This is to establish a primary contract for the annual supply of hot mix asphaltic concrete to be used by the Public Works Department for on-going asphalt pavement overlays, pavement repairs, temporary driveways, and utility cut repairs. The primary Vendor will supply the hot mix on an as needed basis and have the materials available for pick-up during normal working hours and days. The contract provides for the purchase of up to 119,000 tons per year, over the six year duration of the contract.

An alternate contract is also being established to serve as a backup in the event the primary Vendor's plant is down or over-booked and paving work and/or repairs must be done. The alternate contract will supply the exact same materials as the primary contract.
