## Subject

Authorize award and execution of a 24-month service requirements agreement with WASTE MANAGEMENT OF TEXAS, INC., or one of the other qualified bidders to IFB-BV No. SDC0174, for residential refuse dumpster collection services for the Austin Resource Recovery Department in an estimated amount not to exceed \$644,648, with three 12-month extension options in an estimated amount not to exceed \$322,324 per extension option, for a total estimated contract amount not to exceed \$1,611,620.

# Amount and Source of Funding

Funding in the amount of \$107,441 is available in the Fiscal Year 2011-2012 Operating Budget of the Austin Resource Recovery Department (ARR). Funding for the remaining 20 months of the original contract period and for the extension options is contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

### **PRICE ANALYSIS**

- a. Adequate competition
- b. Eighty six notices were sent, including 11 MBE and 1 WBE firms. Three bids were received, with no responses from the MBE /WBEs.
- c. The pricing offered represents an 23% increase to the last contract award in May 2007. This increase can be attributed to the increase in fuel costs and the industry rates.

- a. The recommended bidder submitted the lowest total price offer and earned the highest overall score for the Invitation for Bid Best Value.
