

**ORDINANCE NO. 20120628-085**

**AN ORDINANCE WAIVING CERTAIN FEES AND REQUIREMENTS, AND AUTHORIZING PAYMENT OF CERTAIN COSTS FOR THE CITY CO-SPONSORED AUSTIN SYMPHONY JULY 4<sup>TH</sup> CONCERT AND FIREWORKS EVENT WHICH WILL BE HELD ON JULY 4, 2012.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The Austin Symphony July 4<sup>th</sup> Concert and Fireworks event will be held on July 4, 2012 at Auditorium Shores.

**PART 2.** Council waives certain fees and requirements, and authorizes payment of certain costs for the Austin Symphony July 4<sup>th</sup> Concert and Fireworks event as follows. Fees that have been paid shall be reimbursed.
