1. Vice Chair Francell made a motion to approve the minutes of the Parks and Recreation Board Meeting of April 24, 2012. Board Member Perales seconded. The motion carried on a vote of 7-0.

Chris Herrington of Watershed Protection covered water quality testing and results. Jose Guerrero, Assistant Director of Watershed Protection, spoke on the structural engineering of the bridge on Lakewood Drive. Dave Juarez, Assistant Director of Parks and Recreation spoke on filling in the scour hole. Mike Personett wrapped up the presentation with information on removing gravel and other debris from the creek.
