HISTORIC LANDMARK COMMISSION JULY 30, 2012 DEMOLITION AND RELOCATION PERMITS HDP-2012-0235 615 WEST ANNIE STREET

PROPOSAL

Demolish a house of unknown age.

ARCHITECTURE

One-story, roughly rectangular-plan hipped-roof frame transitional cottage with a partial-width inset porch on round posts; 1:1 fenestration with a bay window on the right side of the house and a leaded Queen Anne-style window on the front of the house to the left of the front porch.

RESEARCH


City permits indicate that the house was moved onto the site in 1958 from an unknown location. There appears to have been a house here in the late 1940s with an address of 619 West Annie Street - the 1949 city directory shows it as under construction. Neither address of 615 nor 619 West Annie appear in the 1952 city directory and the city directories of 1953, 1954, 1955 and 1957 show that whatever structure was at 615 West Annie Street was vacant. The 1958 directory does not list the address at all, perhaps indicating that whatever structure had been there in the mid-1950s was then gone. The city building permit shows that Walter Garcia moved the house onto the lot in October, 1958; he and his wife Nellie lived there until the late 1970s – later directories show their son, Jesse J. Garcia lived in the house through the 1990s. Walter and Nellie Garcia had previously lived in a house at 709 West Elizabeth Street – city building permits show that house was built in 1956, and the 1935 Sanborn map shows the lot as vacant, so it seems clear that the house currently at 615 West Annie Street was not the house the Garcia family lived in on West Elizabeth Street. Walter Garcia was a serviceman and warehouse manager for Cabaniss-Brown, a large Austin furniture company. Jesse J. Garcia, their son, worked for J.C Penney.

STAFF COMMENTS

The house does not appear in any City survey.

STAFF RECOMMENDATION

Encourage relocation over demolition, but there does not seem to be any additional information about the original location of the house to determine its pre-1958 history. All of the members of the Garcia family who lived in this house have passed on, and efforts to find their descendants to determine the original location of the house have not been successful. However, the house is a fine example of a ca. 1910s transitional style cottage with a Queen Anne-style window in the front with a leaded glass transom, and a projecting bay window on the right side of the house, and if it is structurally sound and capable of being moved, that would be staff's recommendation – to allow it to be re-used and preserved in another location.
