Authorize award and execution of a 36-month requirements supply contract with LEXIPOL LLC, to provide a web-based law enforcement policy manual and daily training bulletins for the Austin Police Department in an estimated amount not to exceed \$155,850, with three 12-month extension options in an estimated amount not to exceed \$51,950 per extension option, for a total estimated contract amount not to exceed \$311,700.

Amount and Source of Funding

Funding in the amount of \$13,450 is available in the Fiscal Year 2011-2012 Operating Budget of the Austin Police Department. Funding for the remaining 35 months of the original contract period and extension options is contingent upon available funding in future budgets.
