2. Adoption of agenda.

3. Citizen Communication: General

4. Approval of minutes – May 9, 2012 Commission Regular Meeting.

The minutes from the Commission regular meeting of May 9, 2012 was approved on Commissioner Rosenthal's motion; Commissioner Ramsey's second on a vote of 5-0-0. (Commissioner Touvell absent)

5. Presentation from GTOPs awardee, Skillpoint Alliance. (Lainie Duro) (wp2)

Ms. Duro announced that Skillpoint Alliance's GTOPs funded program formally known as Community Technology Training Center Program will now be known as Empower Computer Literacy Program. This is a mobile learning center.

The mobile learning center has been parked at Mendez Middle School and Del Valle. It is very high tech and can fit 21 laptop computers with monitors. It also has a satellite dish for high speed internet.

In addition, the mobile learning center helps with their Science, Technology, Engineering, and Mathematics (STEM) program and helped build a relationship with Dove Springs Community School Alliance.

GTOPs funding has supported the training of 587 people and since 2008 they have taken 2,254 courses and that represents 23,000 service hours.

Rondella Hawkins, City of Austin Office of Telecommunications & Regulatory Affairs (TARA) Officer gave the Legislative, Regulatory and Policy update which included updateds on INet deactivation; PEG channels coordination for equipment purchases; Austin Independent School District PEG equipment purchases; H.R. 3523 Cyber intelligence sharing and protection Act (CISPA) of 2011; FCC launches Connect American Fund; H. r. 1746 CAP Act; FCC Reform Act Legislation; FCC Basic Tier Encryption NPRM; H.R. 1002 Wireless Tax Fairness Act of 2011; State sales tax collection on Internet Sales; FCC Notice of Inquire on Broadband Deployment.

9. Staff update on Grant for Technology Opportunities Program (GTOPs) (John Speirs) (wp2)

John Speirs, Program Coordinator with the City of Austin Office of Telecommunications & Regulatory Affairs reported that FY 2011 GTOPs has two grant contracts coming to a close which will final out that year' grants.

Working toward finalizing the set up of FY 2012 contracts. Working with awardees for the online grant management tool.

10. Report from Open Government Working Group. (Rosenthal) (wp4)

Commissioner Rosenthal reported:

Staff presented a first draft of an Open Government Directive. The draft used the "Open Government Initiative" (http://opengovernmentinitiative.org/) as a starting base. One major change is the addition of "Accessible and Emerging Technologies and Tools" section.

The Working Group (WG) members will review the draft and provide feedback on: general direction, metrics for progress and participation, and policy issues. Once WG and management feedback are incorporated, we'd like to arrange a presentation to the Commission. Tentative target is August.

Staff presented a draft outline of an Open Government Handbook, and requested WG support to help develop the content. We envision this to be a living document, housed on the city website. We'd like to use a development platform that facilitates migration to the final publish platform, which may be something such as the Drupal "book" module. Staff will propose a development platform, and then we will move forward.

We discussed hosting a "user forum" to bring open government and open data enthusiasts together, in a face-to-face meeting, to exchange information and provide feedback. We will try to assess interest, to identify how such an event could be structured for best success.

The working group will meet next in July.

11. Report from Community Technology Assessment Working Group. (Quintanilla) (wp3)

Commissioner Quintanilla reported that this group is still in the planning stages on how to disseminate the findings of the Community Technology survey so they can get the information out to the state holders for a their funding proposals. The next meeting is scheduled for August

12. Staff presentation on FY 2012-2013 Telecommunications & Regulatory Affairs budget. (Rondella Hawkins) (wp6)

Rondella Hawkins, City of Austin Office of Telecommunications & Regulatory Affairs (TARA) Officer gave an overview of FY 13 budget.
