## ORDINANCE NO. 20120802-035

AN ORDINANCE VACATING 3,254 SQUARE FEET OF LAND OUT OF SOUTH LAMAR BOULEVARD, IN THE ISSAC DECKER LEAGUE, CITY OF AUSTIN, TRAVIS COUNTY, TEXAS, AND BEING THAT SAME TRACT OF LAND ORIGINALLY CONVEYED TO THE CITY OF AUSTIN (CALLED 3,251 SQUARE FEET) VIA STREET DEED, RECORDED IN VOLUME 10455, PAGE 951 OF THE REAL PROPERTY RECORDS OF TRAVIS COUNTY, TEXAS, TO ROBERT S. ELLIS, JR.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- **PART 1.** Council approves the vacation of 3,254 square feet of land out of South Lamar Boulevard, in the Issac Decker League, City of Austin, Travis County, Texas, and being that same tract of land originally conveyed to the City of Austin (called 3,251 square feet) via street deed, and more particularly described in Exhibit A, attached to and incorporated as part of this ordinance.
- **PART 2.** The area being requested for vacation will be used to return the applicant's tract of land to its original size.

THENCE with the common line between Fine Art Services, Inc. and said 3,251 square feet tract, N 59°38'06" W 52.59 feet to a calculated point at the common westerly corner between said tracts of land, for the west corner hereof:

THENCE with the westerly line of said 3,251 square feet tract of land, and with a curve to the right whose central angle is 02°32'43", radius is 1393.48 feet, arc length is 61.91 feet, and whose chord bears N 37°15'09" E 61.90 feet to a calculated point at the common westerly corner between said 3,251 square feet tract and said 3,237 square feet tract, for the north corner hereof;

THENCE with the common line between said 3,251 square feet tract and said 3,237 square feet tract, S 59°55'05" E 52.64 feet to the PLACE OF BEGINNING and containing a calculated map area of 3,254 square feet of land, more or less.






