This contract is for an employee paid Pre-Paid Group Legal Plan for City employees. Some of the highlights of this plan are: waiver of premium for surviving spouse of deceased employee for remaining year to close estate and settle legal issues; waiver of premium for employees in National Guard/Military Reserve while on active duty; legal hotline; preventive legal; major trial services; adoption; wills; court and administrative proceeding services; consumer protection; unlimited for uncontested divorce; no benefit waiting periods (including divorce); coverage allowed more than one time per year per family on the majority of benefits; offers Do It Yourself online documents; and an education center free to all employees.

On June 28, 2012 City Council authorized staff to award and negotiate a contract with ARAG in response to the Request for Proposal No. JSD0121 to provide group prepaid legal services. The Human Resources Department and Purchasing Office negotiated an increase in the number of hours for contested divorce coverage from 10 to 25 hours with a 25% reduced fee beyond the 25 hours. This resulted in a monthly increase to the Employee Only coverage from \$10.80 to \$10.90 and Employee and Family/Domestic Partner and Children coverage from \$12.50 to \$14.80. The rate increase is reflected in the overall contract amounts above. Rates are guaranteed for the first 36-months. The rate increase for the 1st option, 2nd option and 3rd option will not exceed 7.5% for each option.

The total amount for the initial contract period, January 1, 2013 through December 31, 2015 is estimated at \$2,301,000. The three options, if exercised, will extend the contract through December 31, 2018.

The estimated contract amounts were based on enrollment increasing 7.5% for the first year due to no waiting period for divorce, added coverage and a lower Employee and Family/Domestic Partner and Children rate. Subsequent years are estimated at a 7.5% increase in enrollment.

An evaluation team of benefits staff from the Human Resources Department evaluated the proposals based on conformance to the scope of work, demonstrated applicable experience, personnel qualifications, evidence of good organization and management practices, and total evaluated cost. The recommendation for award is to ARAG Services LLC., the best evaluated proposer offering the lowest cost to the City.
