INCREASE FUNDING FOR MEXIC-ARTE MUSEUM AND AFFORDABLE HOUSING 8/16/12

My name is Stuart Harry Hersh, and like most in Austin, I rent. I am solely responsible for the content of this message.

I support affordable housing funding so that my brothers and sisters who can not afford housing in the marketplace have greater access to housing that is safe, located in mixedincome neighborhoods, accessible to people with disabilities, reasonably-priced, and transit-oriented. Safe, mixed-income, accessible, reasonably-priced and transit-oriented, what we call S.M.A.R.T. Housing.

I support Mexic-Arte Museum's funding request for \$5 million dollars so that my sisters and brothers, young and old, who have been served and will be served by Mexic-Arte can enjoy this experience in a new, iconic museum in the future.

Yesterday, you could not find any money for the Mexic-Arte. Today, I suggest that you could reduce the affordable housing amount that you approved yesterday by \$5,000,000 to fund Mexic-Arte while actually increasing your proposed investment in affordable housing over the next 6 years.

In 2000, you created the Housing Trust Fund with \$1,000,000 funding and approved a 40% set-aside of certain property tax revenue in the Urban Core from sites that were not on the tax rolls in 1997. This funding was supposed to be in perpetuity. If you ask the City Manager to find a way to carry out this adopted policy in next year's budget and for the next 6 years, your investment in General Obligations with voter approval and Housing Trust Funds would be at least \$1,000,000 greater than what was adopted yesterday and proposed in the City Manager's budget.

This is only true if you require Housing Trust Fund dollars for affordable housing, not \$557,000 in staffing costs that are currently proposed. Next year's \$1,000,000 could go for home repair, which could free \$400,000 in Community Block Grant funds for Permanent Supportive Housing in very high and high opportunity neighborhoods, thus promoting the geographic dispersion and housing preservation we all are seeking.

This is a win for affordable housing and a win for Mexic-Arte Museum. The \$557,000 staff funding challenge; \$600,000 for housing planning and initiatives; and other housing needs identified but not proposed for funding can also be addressed if there are answers to the Open Records Request filed on 8/2/12 on potential budget windfalls. I have attached a copy for your review.
