Additional Backup Information							
Since the initial funding in 1988, ATI has worked with over 200 companies, helping them raise over \$1 billion and create thousands of jobs and millions of dollars in taxes. It is estimated that the activities of ATI member companies contribute \$20-30 million of economic impact to the Austin region per year. In the last four years, ATI has incubated over 70 companies, helping them raise over \$150 million in investment capital, with \$300 million in company exit value. Hundreds of direct and indirect jobs have been created by ATI member companies during the last four years. Under the recommended agreement, the City will provide \$190,000 during FY13 to assist ATI in providing strategic business consulting services to high technology startup companies that specialize in the IT/wireless industry. This contract may be extended on an annual basis for up to four (4) additional one-year terms. These services include, but are not limited to, market strategy, market validation, product strategy, fundraising, customer acquisition, hiring of key management and development of appropriate means to showcase the startups at conferences and other events of

importance to the IT/wireless industry.

ATI will develop a marketing and education campaign to highlight Austin as a center of entrepreneurial activity and promote local companies in the IT/wireless industry. This campaign will include networking and educational events in Austin and the showcasing of ATI's capabilities at major IT/wireless conferences and trade shows.

ATI-IT/Wireless reporting requirements to the City of Austin include the following:

- Each quarter ATI IT/Wireless will deliver a report to the City of Austin that highlights the progress made by ATI IT/Wireless in achieving each of the objectives set forth in this scope of work document. This report is to be distributed to City Council each quarter.
- Report is due to the City of Austin within 60 days of end of reporting quarter.
- An annual report, which may contain the final quarterly report, is due on or before sixty (60) days following the end of the final quarter of this contract (September 30, 2013).
- In conjunction with this annual report, ATI-IT/Wireless shall make a summary presentation in person to the City Council. ATI will make this presentation prior to the adoption of the 2013–2014 Budget.
