#### Subject

Authorize award and execution of a 12-month requirements service contract with AAR INC., or one of the other qualified bidders for IFB-BV No. CE A0018, to provide lead removal and abatement services at the Austin Police Department's indoor and mobile shooting range in an estimated amount not to exceed \$82,040, with five 12-month extension options in an estimated amount not to exceed \$86,142 for the first extension option, \$90,449 for the second extension option, \$94,972 for the third extension option, \$99,720 for the fourth extension option, and \$104,706 for the fifth extension option for a total estimated contract amount not to exceed \$558,029.

## Amount and Source of Funding

Funding in the amount of \$6,837 is available in the Fiscal Year 2011-2012 Operating Budget of the Austin Police Department. Funding for the remaining 36 months of the original contract period and extension options is contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

## Additional Backup Information

This contract will provide on-site lead removal and abatement disposal and/or destruction of lead for the Austin Police Department (APD).

AAR, Inc. shall provide removal and disposal of lead fragments and dust that are generated from the use of the APD Academy Training firing range and Mobile Forced Option Simulator (Shooting Trailer).

In order to determine the best-value to the City, evaluation criteria included cost, contractor qualifications, individual qualifications, recycling, prior experience specific to indoor shooting range facilities, and local presence.

This request allows for the execution of a contract with a bidder, who provides the best value to the City, that Council selects. If this bidder does not execute a contract with the City, staff will return to Council so that Council may select another best value bidder and authorize a contract with this bidder.
