- Support capacity building and community transformation goals of Colony Park area residents and stakeholders.

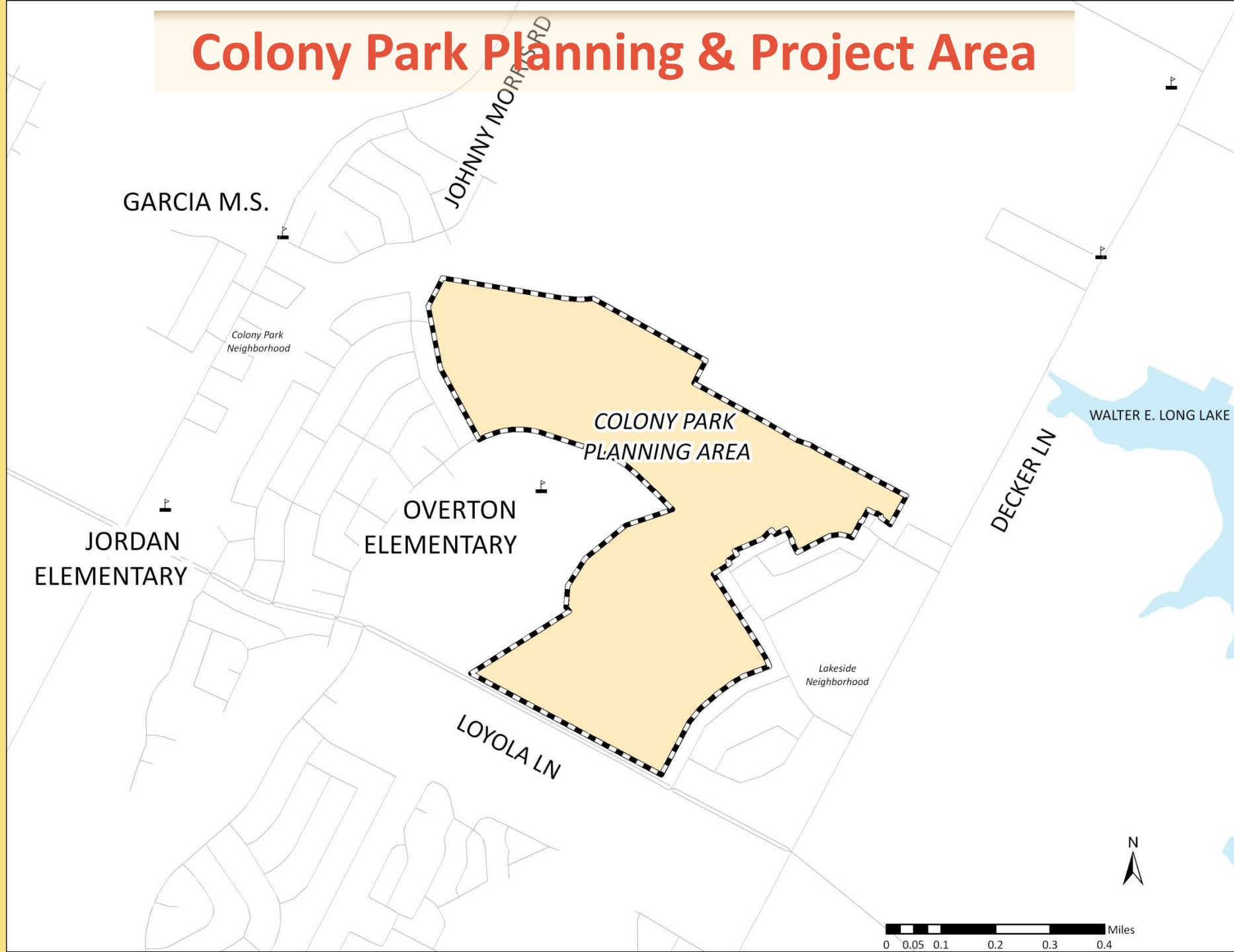


HUD Livability Principles

6. Value communities and neighborhoods.











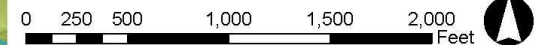
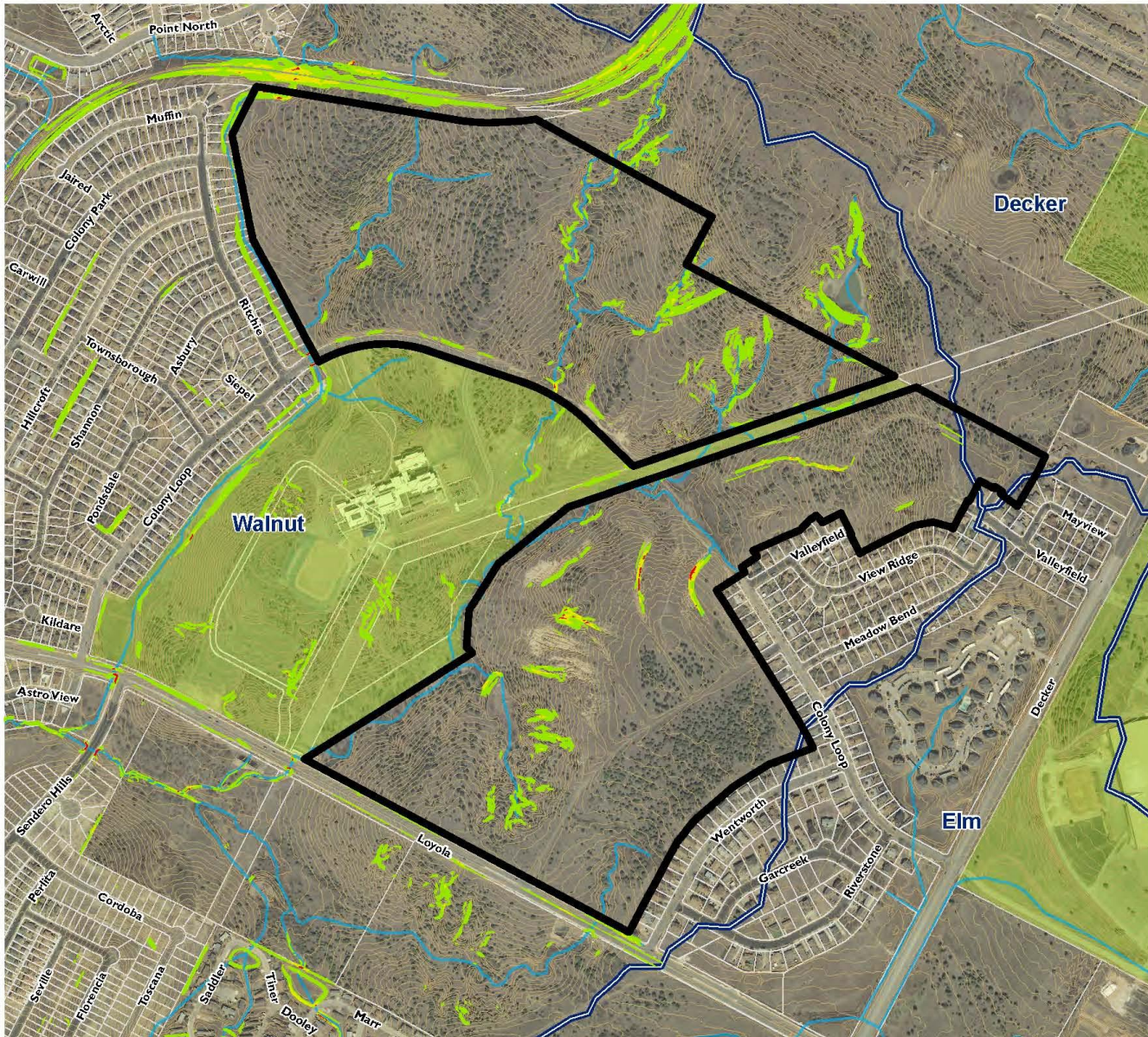

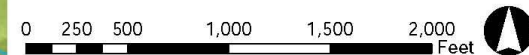
