<p>In August, 1998, City Council approved the original contract with the Capital Area Training Foundation (CATF), now Skillpoint Alliance, to operate computer labs at Austin Independent School District, otherwise known as the Community Technology Training Centers (CTTC). Currently, community residents can receive the services at computer labs located at Travis High School and Reagan High School. Through previous actions, City Council approved continuation of the CTTC program with Skillpoint Alliance through fiscal year 2011 – 2012. The current proposal would re-name the existing CTTC Program to The Empower Computer Literacy Program (ECLP) and would operate computer labs at Travis High School, HACA – Georgian Manor, and the Skillpoint Office Computer Lab.</p> <p>The ELCP program offers short and long-term classes designed to bring individuals into the digital age through technology training. The ELCP program provides computers and technology training in three geographical areas of Austin (Travis High School, HACA – Georgian Manor, and the Skillpoint Office Computer Lab) where computers and technology training are greatly needed. The extra computers provided to these schools through this program allow more high school students to learn technology skills. During the evening hours, these same classes are offered to adults. New technology skills increase participants’ employability and expand the workforce skills in Austin that are important to a vibrant economy.</p> <p>Under the program, Skillpoint Alliance has leveraged over \$3,250,000 of in-kind contributions of classroom space, hardware, software and custodial services from AISD and has received private sector cash support from the Michael and Susan Dell Foundation, Dell Connected Communities, Department of Education, IBM, Southwestern Bell, WorkSource, 21st Century Grant (TEA), Travis County, Texas Pioneer Foundation, Microsoft Elevate America, and the Greater Austin Chamber of Commerce. In addition, Skillpoint Alliance receives in-kind contributions annually from various private sector companies including Microsoft Corporation, AMD, Titus Electric, Magnum Custom Trailers, Seton, St. David’s and Edvance Research. Skillpoint Alliance has worked closely with the City in creating, developing and enhancing the ECLP program. This close collaboration has helped Skillpoint Alliance become a nationally recognized best practices model of technology training and it has received national best practices recognition from the Ford Foundation, as well as regional recognition in the form of three Digital Inclusion Awards at the 2010 GTOPS 10th Anniversary Gala.</p>
