



Austin Mayor's Committee for People with Disabilities
REGULAR MEETING MINUTES

(13, August, 2012)

The Austin Mayor's Committee for People with Disabilities convened in a regular meeting on 13, August, 2012 at 301 West 2nd Street in Austin, Texas.

Chair Jesus Lardizabal called the Board Meeting to order at 12:05 PM

Board Members in Attendance: Chair Jesus Lardizabal, Chip Howe, Kathy Kasprisin, Norman Kieke, George Luc, and Tanya Winters. Absent Ron Lucey

Staff in Attendance: Dolores Gonzalez

1. **Approval of Minutes:** A motion was made by Commissioner Kathy Kasprisin to approve the July 09, 2012 minutes; the motion was seconded by Commissioner Norman Kieke. The motion was approved unanimously by all.
2. **OLD BUSINESS** A motion was made by Commissioner Norman Kieke, to submit the My Medicaid Matters resolution to Council, the motion was seconded by Commissioner Tanya Winters. The motion was approved unanimously by all.
 - Dolores will work with Commissioner Howe on finalizing the wording on the resolution and submit to members to take to their individual council members.

3. NEW BUSINESS

Presentation: Ayo Oppenheimer, local citizen, -A discussion proposing a new and innovative way to embrace differences and empower persons with disabilities to share their stories while doing public outreach to the Austin community.

- Introduction
 - Ayo is new to Austin and tells her story of meeting an amputee, who describes to her how the general public still views people with disabilities as different.
 - After this meeting Ayo came up with the idea of having a public forum that would give people with disabilities a chance to speak about their journey and for the public to ask questions in a safe environment.
 - Storytelling is becoming more popular, because it is a good way to educate and outreach to the public.
 - Austin should consider a month long story telling program as a standalone, to piggy back off of other events during the month of October.
 - The event would include a select few presentations from a number of people in the disability community, followed by Q&A and organizational booths giving the general public an interactive experience (experiencing blindness, deafness, etc).
 - Venues such as VSA, theaters, and the Mexican American Cultural Center could be used to host the month long event.
 - The event would be geared towards bringing disability awareness to the general public giving an opportunity for people with disabilities and their families to tell their stories.

- Many of the major disability advocacy organizations and agencies (ARCIL, DARS, DADS) have expressed interest in this month long event. Currently there is no such event being held in the Austin community.
 - Ayo would like to build on these ideas but she is very flexible on receiving input to elaborate further to bring the event to manifestation.
- AMCPD Discussion
- Commissioner Tanya Winters suggested partnering with VSA Texas Actual Lives program, a drama troupe of people with disabilities.
 - Commissioner George Luc and Commissioner Winters volunteered to take point on this project for the committee. AMCPD member Mitch Rappaport also volunteered to help.
 - Commissioner Luc commended Ayo on suggesting this event for the community.
 - Commissioner Winters suggested to Ayo to start with VSA Texas and talk with other event organizers from White Cane Day and Disability Mentoring Day to collaborate for October.
 - Chair Jesus Lardizabal is supportive of such an event, but needs concrete details before he can commit any committee resources.

COMMITTEE REPORTS:

Access & Youth Committee – Chair Tanya Winters

- Chair Tanya Winters reported that the Austin Access Awards presentation was held on August 2nd at City Council Chambers. She also reported that letters for non-winners have gone out and Pictures of winners with Mayor Lee Leffingwell would be sent via email. The winners that were not able to attend were invited to the September 17 AMCPD meeting, to receive their awards.

Awards & Employment Committee – Liaison Dolores Gonzalez for Chair Ron Lucey

- Committee Liaison Dolores Gonzalez reported that bids to host the AMCPD Employment Awards have been finalized. This year's Awards will be held at The Crowne Plaza Austin (located at 6121 N IH 35) on Monday October 29, 2012.
- Dolores also reported that funds for this year's award expenses including venue, printing and awards has been encumbered for fiscal year 12.
- Dolores announced that Commissioner Ron Lucey and Awards Committee Member Katie Navine had secured several judges for the program including Dennis Borel and Robert Alexander, area manager for DARS.
