#### Subject

Authorize award and execution of Amendment No. 1 to a contract with A-1 SCALE SERVICE, INC., to provide truck scale inspection, maintenance and repair services for the Austin Resource Recovery Department, to increase the final 12-months of the original contract term in an estimated amount not to exceed \$20,000, and add three 12-month extension options in an estimated amount not to exceed \$20,000 per extension option, for a revised estimated total contract amount not to exceed \$120,000.

#### Amount and Source of Funding

Funding in the amount of \$20,000 is available in the Fiscal Year 2012-2013 Operating Budget for the Austin Resource Recovery Department. Funding for the remaining option will be contingent upon available funding in future budgets.

#### Additional Backup Information

This contract is for the purchase of truck scale inspection, maintenance and repair services for Austin Resource Recovery Department.

This contract was competitively bid and awarded in 2009, in an amount of \$20,000 for the initial 12-months of a 36-month contract. Funding for years one and two of the initial 36-month contract were added administratively. The recommended council action is to approve Amendment No. 1 in the amount \$20,000 for the final 12-months of the initial contract period, and the authorization to enter into the three 12-month option periods when appropriate, for a final contract value of \$120,000.
