## Additional Backup Information

On January 26, 2012, Council approved the original contract under the Texas Procurement and Support Services Cooperative Purchasing Program (TPASS) for various size residential garbage carts and single stream recycling carts for Austin Resource Recovery (ARR) Department, in an estimated amount not to exceed \$1,678,961.

This proposed amendment is for the purchase of an additional 4,200, 64-gallon residential garbage carts including lid graphics. This purchase is necessary to provide ARR with a sufficient supply of 64-gallon garbage carts readily available to replace existing customers' broken carts and to issue new carts to new customers on an as-needed basis.
