Authorize award and execution of a 12-month requirements supply contract with CONSOLIDATED TRAFFIC CONTROLS, to provide pedestrian push buttons and latching control units for the Transportation Department, in an estimated amount not to exceed \$145,000, with three 12-month extension options in an estimated amount not to exceed \$145,000 for each extension option, for a total estimated contract amount not to exceed \$580,000.

Amount and Source of Funding

Funding in the amount of \$145,000 is available in the Fiscal Year 2021-2013 Operating Budget of the Transportation Department. Funding for the remaining 24 months of the original contract period and extension options is contingent upon available funding in future budgets.

Fiscal Note

There is no unanticipated fiscal impact. A fiscal note is not required.

Additional Backup Information

This contract is for the purchase of pedestrian push buttons and latching control units. These units will be installed at Traffic Signal locations within the City of Austin at new and existing locations and are used to place pedestrian calls into the traffic signal control equipment causing the Walk light to turn on.

The Transportation Department currently maintains approximately 920 signalized intersections. There is currently have an older style pedestrian button without an LED indicator installed at approximately 700 of those intersections. This button is the new standard for the City of Austin. These buttons will be used to replace existing old style buttons as well as approximately 120 for new installations. Inventory is kept on hand to replace malfunctioning or damaged pedestrian push buttons within 2 hours or less from the time the receive the report.
