

ORDINANCE NO. 20121018-063

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO REPOSITION THE SCHOOL ZONES ON BLUEBONNET LANE AND RUNDELL PLACE, AND ADD A PORTION OF ANN ARBOR AVENUE TO THE LIST OF STREETS HAVING A MAXIMUM SPEED LIMIT OF 20 MPH AT CERTAIN TIMES FOR STUDENTS ATTENDING ZILKER ELEMENTARY SCHOOL; AND TO PROVIDE FOR EMERGENCY PASSAGE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) is amended to read:

Bluebonnet Lane from Blue Crest Drive [~~200 feet north of Holland Drive~~] to 125 [~~200~~] feet north of Rundell Place (Zilker Elementary School). 20 MPH School Zone

Rundell Place from 107 feet east of Paramount Avenue to Bluebonnet Lane [~~to Ann Arbor Avenue~~] (Zilker Elementary School). 20 MPH School Zone

PART 2. Section 12-4-64(D) (*Table of Speed Limits*) is amended to add:

Ann Arbor Avenue from 403 feet north of Holland Avenue to Rundell Place (20 MPH School Zone)

PART 3. The amendments made in this ordinance are based on the results of a traffic engineering investigation, or "speed study," attached as Exhibit "A".

PART 4. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing entries reordered accordingly.

PART 5. Council finds that school is in session, and the need for a school zone at this site constitutes an emergency. Because of this emergency, this ordinance takes effect

immediately on its passage for the immediate preservation of the public peace, health and safety.

Subject: Reduced Speed School Zone Investigation

Location: Bluebonnet Lane (extending), Rundell Place (extending), Ann Arbor Avenue

Date(s) of Previous Investigation: None

A traffic engineering investigation has been conducted to determine if a reduced speed school zone should be installed on Ann Arbor Avenue and if existing school zones should be modified on Bluebonnet Lane and on Rundell Place for students attending Zilker Elementary School.

Austin Independent School District School (AISD) and the Public Works Child Safety Program have revised the parent drop off / pick up location and the Austin Transportation Department installed two additional crosswalks for the 2012-2013 school year. Figure 1 presents a map of the study area.

The following information was collected and analyzed for this determination.

Proximity of the School Crossing to the School

The new crosswalks are adjacent to Zilker Elementary School property. The adjacent land uses are primarily residential as the Zilker and Barton Hills Neighborhoods abut Bluebonnet Lane, Rundell Place and Ann Arbor Avenue.

Pedestrian Count

Because the 2012-2013 school year has not begun, no students have been counted crossing at the new crosswalk locations.

Existing School Zones

The existing zones are on Bluebonnet Lane from 200 feet north of Holland Avenue to 200 feet north of Rundell Place and on Rundell Place from Ann Arbor Avenue to Bluebonnet Lane.

Presence of Adult Crossing Guard or Student Safety Patrol

The City's Child Safety Program has committed adult crossing guards at the three crosswalk locations. There are three guards currently working these crossing locations.

Crash History

Austin Police Department's crash database was culled for crashes near the study locations between September 2011 and September 2012. None were reported during this time period.

Sight Distance

No sight distance issues at the new or existing crossing locations

Sidewalks and Ramps

There are sidewalks, curb ramps and marked crosswalks at all existing and new school crossing locations. Sidewalks are continuous around the school property.

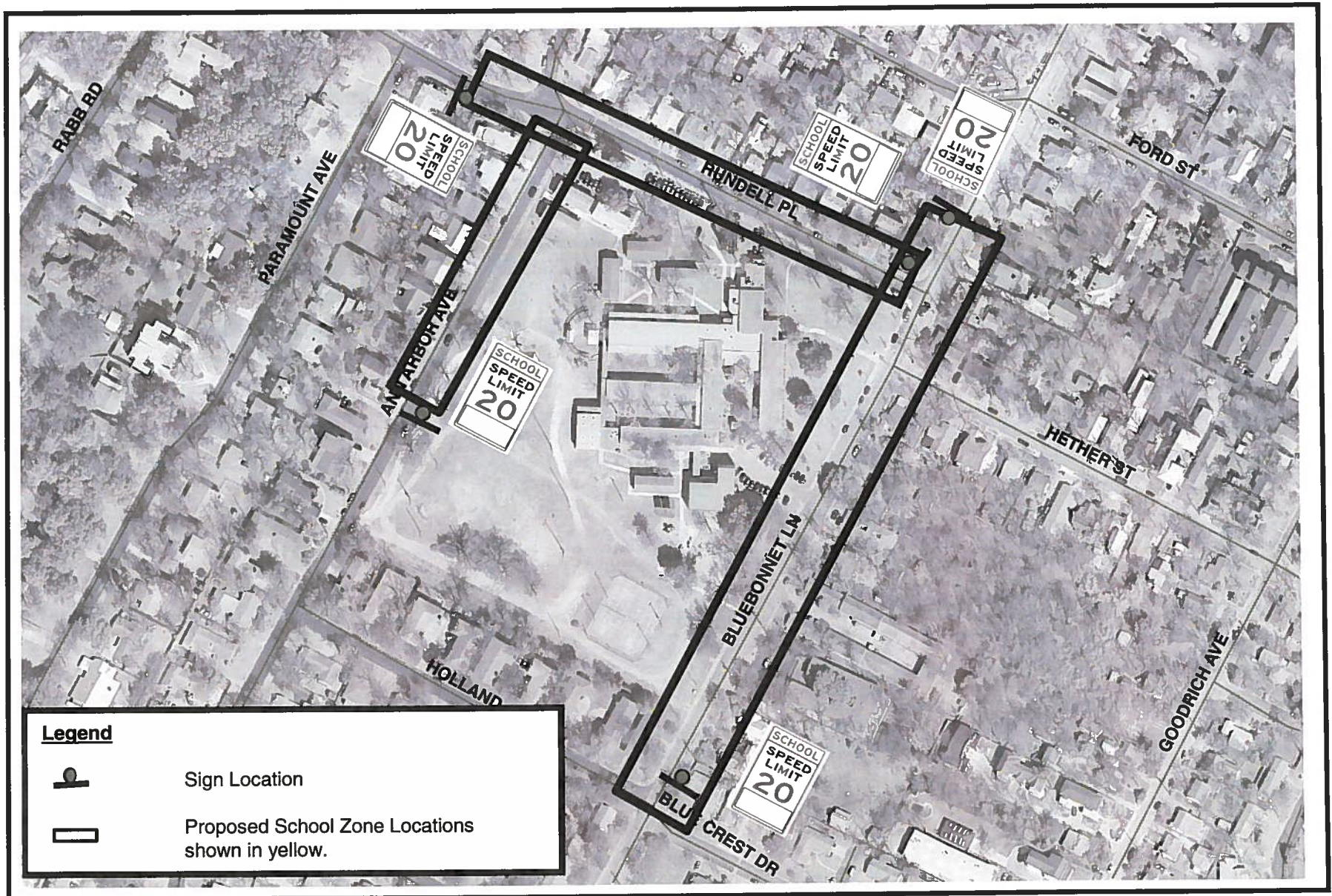
Recommendation

Based on the analysis of this information, it is my engineering judgment that a reduced speed school zone of 20 miles per hour be installed on Ann Arbor Avenue from 403 feet north of Holland Avenue to Rundell Place. It is also recommended that the existing school zones be modified on Bluebonnet Lane from Blue Crest Drive to 125 feet north of Rundell Place and on Rundell Place from 107 feet east of Paramount Avenue to Bluebonnet Lane and operate between 7:00 AM and 9:00 AM and 2:00 PM and 4:00 PM.
