The Council accepts and approves the returns for the special election, as tabulated and canvassed, and declares that Proposition Nos. 1, 2, 3, 4, 5, 7, 9, 10, 11, 12, 13, 14, 16, 17, and 18 are adopted.

With this canvass, Council is only making official the precinct returns received from the counties and taking no other action.
