Authorize award, negotiation, and execution of Amendment No. 1 to a requirements service contract with CSDC SYSTEMS, INC., for maintenance and support for the AMANDA software system and for additional modules and services as part of the system upgrade for the Communications and Technology Management Department in an estimated amount not to exceed \$450,940 for a total revised estimated contract amount not to exceed \$1,968,749.

## Amount and Source of Funding

Funding in the amount of \$290,000 is available in the Fiscal Year 2012-2013 Operating Budget of Communications and Technology Management. Funding for the remaining contract period is contingent upon available funding in future budgets.

## Additional Backup Information

This amendment is for the continuation of maintenance and support for the AMANDA PIER software system which was implemented by the City in the spring of 2007. The AMANDA system manages, tracks and produces reports on land development and review activities including permits, trade licenses, escrow, inspections, neighborhood planning, zoning and all activities in the One Stop Shop. In addition, it manages, tracks and produces reports for Solid Waste Services code enforcement activities such as housing and zoning violations and Health and Human Services Environmental and Consumer Health Division activities such as restaurant and pool inspections and rodent control. The contract will also include authority to purchase additional modules and services as part of the AMANDA System upgrade.

CSDC Systems, Inc., St. Petersburg, FL, is the developer and owner of the AMANDA application and is the only software provider authorized to provide AMANDA maintenance and support. The source code for the AMANDA application and the use of the data model are contractually controlled by CSDC Systems, Inc. There are no other entities, companies or individuals that can legally provide upgrades and maintenance for the application client interface.
