

ORDINANCE NO. 20121206-021

**AN ORDINANCE SETTING THE COUNCIL MEETING SCHEDULE FOR
CALENDER YEAR 2013.**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1.
