PROPOSAL

Demolish a ca. 1940 house.

ARCHITECTURE

One-story, rectangular-plan, side-gabled frame house with a front-gabled over-door hood over the front door; single and paired 1:1 fenestration; ca. 1964 addition to the right side with sliding windows.

RESEARCH


There are no building or utility permits to confirm the date of construction of this house, but city directories do not list the address until the directory of 1941, which shows Robert W. Turner, a mill-man at Calcasieu Lumber Company, and his wife, Gladys, as the renters. The 1940 U.S. Census shows Robert and Gladys Turner at an address on Gonzales Street, so it appears that they were the first occupants of the house. The house remained a rental unit with tenants including a brakeman for the Southern Pacific Railroad and a paint salesman, until around 1954, when it was purchased by Joe and Refugia Briones, who lived here for a short time. By the late 1950s, the house was the home of Alfredo and Annie Montana. Alfredo Montana, Jr. had lived at his parents' house on E. 4th Street before moving into this house when he married. He and Annie lived here until 1971, when they divorced; Annie Montana then lived here alone until the early 1980s. Alfredo Montana, Jr. was a warehouseman for Davidson Sash and Door, served a tour in the Coast Guard, and was a driver for Central Freight Lines. He died in 2007.

STAFF COMMENTS

The house does not appear in any City survey.

STAFF RECOMMENDATION

Release the demolition permit. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.

BIOGRAPHICAL NOTES:

Robert W. and Gladys Turner appear in the 1940 U.S. Census as renting a house at 3216 Gonzales Street in Austin. Robert W. Turner was then 24, had been born in Texas, and was a handy-man at a planing mill. Gladys Turner was then 19 and had been born in Texas. She had no occupation listed. The census report reveals that Robert Turner had lived in rural Travis County in 1935. They had no children listed in the census report.

The 1940 U.S. Census report shows Alfred M. Montana, Jr. as the 6-year old son of Alfred and Lola Montana, who lived at 2517 E. 4th Street in Austin. The senior Alfred Montana was a 31-year old Texas-born laborer digging Indian relics for the WPA. Lola Montana had no occupation listed.

MONTANA, Alfredo M. Jr., 73, of Austin died Monday. Rosary 7 p.m. Thursday, Mission Funeral Home, Serenity Chapel. Services 10 a.m. Friday, San Jose Catholic Church. Burial Assumption Cemetery.




