Section 25-8-342 (*Fill Requirements*) – Allow for fill greater than 4 feet, but not greater than 11 feet

Section 25-8-261 (*Critical Water Quality Zone Development*), 25-8-482 (*Critical Water Quality Zone*), and 25-8-514 (*Pollution Prevention Required*), subsection (B) – Allow water quality controls and a single private driveway within the CWOZ

Section 25-8-483 (*Water Quality Transition Zone*) – Allow development shown on the PUD Land Use Plan within the WQTZ

Section 25-8-514 (*Pollution Prevention Required*) – Allow additional impervious cover to exceed 25% and to allow for alternative water quality controls

Note: Section 25-8-514 is part of the Save Our Springs Initiative.

Section 25-8-302 (Construction of a Building or Parking Area) - Allow for construction on slopes greater than 15%.

Section 25-8-341 (Cut Requirements) - Allow for cut greater than 4 feet, but not greater than 10 feet

Section 25-8-342 (Fill Requirements) - Allow for fill greater than 4 feet, but not greater than 11 feet

Section 25-8-261 (Critical Water Quality Zone Development), 25-8-482 (Critical Water Quality Zone), and 25-8-514 (Pollution Prevention Required), subsection (B) – Allow water quality controls and a single private driveway within the CWQZ

Section 25-8-483 (Water Quality Transition Zone) - Allow development shown on the PUD Land Use Plan within the WQTZ

Section 25-8-514 (Pollution Prevention Required) - Allow additional impervious cover to exceed 25% and to allow for alternative water quality controls

Note: Section 25-8-514 is part of the Save Our Springs Initiative.

RATIONALE:

The PUD as proposed would reduce the impact that is currently allowed on the property by shifting the impervious cover away from the CWQZ.

Board also recommends that City of Austin staff move forward in facilitating the use of gray water systems by city residents, which includes showers, baths and sinks other than Kitchen or food-handling as defined in the 2012 Unified Plumbing Code.
