2209 E. 14<sup>th</sup> Street

Applicant: Mary Carroll and Estelle Brown, St. Paul Primitive Baptist Church, and the City of Austin  
City Staff: Steve Sadowsky, Historic Preservation Office, 974-6454  
Staff Recommendation: Recommend historic zoning.

Committee Recommendation: Approve as proposed.

**C. REVIEW OF PERMITS IN NATIONAL REGISTER HISTORIC DISTRICTS**

**1. NRD-2012-031**

**2201 Barton Springs Road/R. E. Lee Ballfields (Zilker Park)**

Proposal: Repair masonry dug-out benches, remove the fencing in front of the dug-out benches and replace the existing fencing on the backstop.

Applicant: Kim McKnight, Parks & Recreation Department

City Staff: Alyson McGee, Historic Preservation Office, 974-7801

Committee Recommendation: Restore the benches and rehabilitate the back stop with appropriate fencing materials. Removal of the fence barriers in front of the benches is acceptable; however their location and design should be carefully documented on a measured site plan and with photographs.

Staff Recommendation: Release the permit per the proposed design with the recommendation that Historic Preservation Office staff review final specifications for masonry repairs and fence material.

Staff Recommendation: Release the permit per the proposed design with the recommendation that in the future the applicant seek review of changes to the property prior to carrying them out as is required by code.

**1506 Preston Avenue (Old West Austin)**

Proposal: Construct a rear and second story addition to a contributing house.

Staff Recommendation: Release the permit with the recommendation that the applicant consider a more compatible addition.
