Authorize award and execution of a 36-month requirements service contract with EAGLE HYDRO BLAST to provide power washing services for various City Departments in an estimated amount not to exceed \$75,150, with three 12-month extension options in estimated amounts not to exceed \$25,050 per extension option, for a total estimated contract amount not to exceed \$150,300.

Amount and Source of Funding

Funding in the amount of \$18,787 is available in the Fiscal Year 2012-2013 Operating Budget of various City Departments. Funding for the remaining 28 months of the original contract period and extension options is contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

This contract will provide power washing services for various City departments at various City locations. The power washing services will be on an as-needed basis and will be performed on, and around, walkways, curbs, and parking area. In addition to power washing, the contractor will also collect and remove trash and debris. The contractor will utilize equipment that reclaims the water used during power washing, thereby reducing surface runoff and the risk of groundwater contamination. This contract will provide labor, supervision, material, and trained personnel. This contract will utilize Occupational Safety & Health Administration (OSHA) and Leadership in Energy and Environmental Design (LEED) approved chemicals including Green Seal and Eco logo Certified Products.

City departments that will utilize this contract include the Aviation Department, Building Services Department, and the Convention Center Department.
