Exhibit A

Geographic Areas for the Community Development Commission

Each of the geographic areas described below have either a Health & Human Services Department neighborhood center or a Parks and Recreation Department recreation center and are designated under City Code § 2-1 -127(B) to have a Commissioner on the Community Development Commission to represent the poor residing in each respective designated area.

1. Colony Park:

North Boundary - US Hwy 290 South Boundary - FM 969 East Boundary - Lindell Lane, Blue Bluff Road, Bloor Road, Gilbert Road, Decker Lake Road West Boundary - Ed Bluestein Boulevard

2. Dove Springs

North Boundary – Ben White Boulevard South Boundary – Brandt Road, Nuckols Crossing Road, Thaxton Road, Salt Springs Road, Colton Bluff Springs Road East Boundary – U.S. Highway 183 West Boundary - South Interstate Highway 35

3. East Austin

North Boundary - East 7th Street South Boundary - Lady Bird Lake East Boundary - Airport Blvd, South U.S. Highway183 West Boundary - North Interstate Highway 35

4. Montopolis

North Boundary- Lady Bird Lake South Boundary - East Ben White Boulevard East Boundary - South U.S. Highway183 West Boundary - South Interstate Highway 35

5. Rosewood-Zaragosa/Blackland

North Boundary- East Manor Rd/Airport Blvd/E. Martin Luther King Jr. Boulevard South Boundary - East 7th Street East Boundary - Ed Bluestein Boulevard West Boundary - North Interstate Highway 35

6. Saint John's

North Boundary- Anderson Lane/Hwy 183 South Boundary - East 51st Street East Boundary - South Hwy 183/Ed Bluestein Boulevard West Boundary - North Interstate Highway 35

7. South Austin

North Boundary - Lady Bird Lake South Boundary - East Ben White Boulevard East Boundary - South Interstate Highway 35 West Boundary - South Lamar Boulevard
