Temporarily closing any portion of a street for a Street Event that requires the public to pay to enter the closure area requires City Council approval under Section 14-8-3 (B) of the City Code. The applicant is in the process of complying with all other requirements for this street event. The Austin Transportation Department recommends approval subject to the applicant complying with all other street closure requirements.
