CONSIDERATION: Ten and No/100 Dollars (\$10.00) and other good and valuable consideration paid by the City of Austin to the Owner, the receipt and sufficiency of which is acknowledged.

WHEREAS, the Restrictive Covenant (the "Original Restrictive Covenant") that was executed by Hi-Plains Savings & Loan Association on or about August 28, 1986 and recorded in Volume 10028, Page 356 of the Real Property Records of Travis County, Texas, as required by the City of Austin as a condition of Zoning Case No. C14-85-288 (Part 45), established certain covenants, conditions and restrictions for the real property more particularly described therein; and

WHEREAS, PPF AMLI Covered Bridge Drive LLC, CBAL Whitecrowe LLC and Covered Bridge Section 8 LLC are the current owners (the "Owners") of Parcels 1, 3A and 3B, totaling approximately 32.025 acres out of the property described in the Original Restrictive Covenant, on the date of this Second Amendment to Restrictive Covenant ("Amendment") and desire to amend the Original Restrictive Covenant as to the Property.

WHEREAS, the Owners of the Property have all been included in an application to the City of Austin for the approval of the Covered Bridge Planned Unit Development (the "PUD"), City Case No. C814-2012-0055.

WHEREAS, the City Council and the Owners agree the Original Restrictive Covenant should be amended.

NOW, THEREFORE, for and in consideration of the premises and mutual promises, covenants, and agreement hereinafter set forth, the City of Austin and the Owners agree as follows:

1. The covenants contained in paragraph no. 1, of the Original Restrictive Covenant, pertaining to Parcel 1, as identified in Exhibit "A" is deleted in its entirety and no longer apply.
2. The covenants contained in paragraph no. 2, of the Original Restrictive Covenant, pertaining to Parcel 3A, as identified in Exhibit "A" shall no longer apply to Parcel 3A, except for any part of Parcel 3A which is outside the PUD and not owned by Covered Bridge Section 8 LLC.
3. The covenants contained in paragraph no. 3, of the Original Restrictive Covenant, pertaining to Parcel 3B, as identified in Exhibit "A" shall no longer apply to Parcel 3B.
4. Except as expressly provided for in this Amendment, each and every one of the terms, conditions, and provisions of the Restrictive Covenant, as set forth in the Restrictive Covenant, shall continue in full force and effect on and after the effective date of this Amendment.
5. The City Manager, or his designee, shall execute on behalf of the City, this Amendment as authorized by the City Council of the City of Austin. The Amendment shall be filed in the Official Public Records of Travis County, Texas.
