MEETING MINUTES

A. CALL TO ORDER

Board Vice-Chair Hayes called the meeting to order at 5:50PM.

B. APPROVAL OF MINUTES

1. Motion made by Board Member Classen, seconded by Board member vanTreeck to approve the UFB meeting minutes of February 20, 2013. Board Vice-Chair Hayes noted the Urban Forestry Board Document Procedures approved at the February 20, 2013 were not attached. He asked that approval of the minutes be tabled and resubmitted at the April 17, 2013 meeting when the document could be attached to the draft meeting minutes. Motion amended to table approval of the minutes until the next meeting. Motion made by Board Member Classen, seconded by Board Member Kite. All in favor. Board Member Maceo abstained. Board Chair Brewer and Board member Fleming absent. Angela Hanson noted new Board and Commission posting rules that will be effective April 1, 2013.

C. CITIZEN COMMUNICATION

The first 4 (four) speakers signed up prior to the calling of the meeting to order are allowed a three-minute allotment each to address their concerns regarding items not posted on the agenda.

Michael Fossum – Project duration ordinances – City Council Item #22 for tomorrow's meeting. Opposed to the item. Requesting UFB members to contact City Council to voice opinion.

Zoila Vega – Parker Lane Trees. Concerned about amount of mulch around the trees. At some points, up to eight inches.

E. DISCUSSION AND ACTION ITEMS

1. Discuss and approve Resolution to City Council Containing Recommendations for Maintenance of Live Oak Trees.

Board Member Kite presented information posted. Photographs of the trees viewed. Motion made by Board Member Maceo to adopt the resolution and recommendations of the UFB Working Group submitted in the backup information. Seconded by Board Member Classen. Angela Hanson, Program Manager, PARD Forestry Unit, stated that the cuts to the trees presented would violate the ANSI A300 Pruning Standards for Care of Trees on Public Property. Existing power lines were discussed regarding location to the trees in question. LCRA lines carry 69,000 volts. Board Vice-Chair Hayes stated that the resolution proposes pruning to leave half of the sprouts as an interim measure until study is completed. Look at cost study to possibly raise the lines. Michael Embesi, City Arborist, stated that the proposed pruning would cause less than 25%. Ray Henning, Line Clearance Supervisor, stated concern of being asked to violate standards set and accepted by the City. Stated pruning should be in accordance with the ANSI standards. Amendments to resolution discussed. Resolution to be included in the body of a memo to City Council. Board Member Maceo made a motion to approve the resolution and recommendations as amended by Board Vice-Chair Hayes, seconded by Board Member vanTreeck. All Board members present in favor.

Board Vice-Chair Hayes noted the GIPPIT has a big emphasis on public lands. Is the Comprehensive Urban Forest Plan focused on public lands? What are we doing on private lands? Goal of Comprehensive Urban Forest Plan serves as model to be considered public education tool.

 PARD partnering with AFD to implement the Firewise program. Volunteer projects and staff to address
 fuel modification requests. Adopted Firewise Community Program standards used for Wildland
 interface areas. Educational components. Board Vice-Chair Hayes requested a briefing at the next
 meeting.

SUBJECT: Draft City Council Resolution Recommended by the Urban Forestry Board

for Maintenance of Live Oak Trees beneath Austin Energy Transmission

Lines in the Gracywoods Neighborhood

The Urban Forestry Board recommends that the City Council consider adopting the following resolution, in order to reach a long-term solution to the ongoing conflicts between the transmission lines and the Gracywoods oaks. RESOLUTION NO.

WHEREAS, the urban forest has social, environmental, cultural, economic, historical, aesthetic, and health benefits for the citizens of Austin.

WHEREAS, the urban forest is an essential part of the City's infrastructure that city policy seeks to protect.

WHEREAS, the urban forest canopy provides shade that reduces energy bills, removes air pollutants, and creates more livable and beautiful neighborhoods.

WHEREAS, in 2006 the City Council established the Tree Task Force, in order to address concerns by the Hyde Park, Hancock, and Eastwoods Neighborhood Associations with Austin Energy's tree trimming and removal program.

WHEREAS, the final Recommendations of the Tree Task Force (May 8, 2006) contain several agreements by Austin Energy, which respond to the strong desire of Austin neighborhoods to preserve their trees to the maximum extent possible. These agreements include the sharing of

vegetation work plans with neighborhoods, in order to provide selective pruning options on a tree-by-tree basis and offer line redesign and relocation options. Austin Energy also agreed to investigate and implement less aggressive trimming strategies.

WHEREAS, in 2007 the City Council passed a resolution, which established the Climate Program and directed the City to significantly reduce greenhouse gas emissions by 2020. Tree preservation is an important means of achieving carbon sequestration to reduce overall greenhouse gas emissions.

WHEREAS, when ordained in 2010 by the City Council, the Heritage Tree Ordinance increased the protection of Protected (19+ inches in diameter) and Heritage (24+ inches in diameter) trees, including prohibitions against excessive pruning.

WHEREAS, Austin Energy is planning to prune a group of live oak trees, including Protected and Heritage trees, located immediately west of Swearingen Drive underneath 138 kiloVolt (kV) transmission lines. These trees are prominent components of the only park serving the Gracywoods and adjacent neighborhoods of north Austin. In order to meet safety requirements, these live oak trees were severely pruned in 2004 and received maintenance pruning in 2009. However, the trees remain healthy and continue to sprout vigorously following pruning; NOW,

THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

In order to both maximize the health of these trees and minimize the amount of foliage that is removed, the City Manager shall direct Austin Energy to take following interim steps:

- 1. This year, only prune the sprout growth that is expected to enter, within the next two years, the critical clearance zone between the tree tips and the transmission lines at their lowest expected sag point. The critical clearance zone shall be carefully defined for each affected tree. Austin Energy shall perform no pruning on sprouts growing at an angular direction away from the transmission lines, while removing no more than 25% of the existing live canopy of any tree.
- 2. Beginning this year, remove less foliage on a two-year pruning cycle rather than more foliage on the current four-year cycle. Avoid cutting back to the main trunk, and instead make pruning cuts to direct future growth away from the critical clearance zone.
- 3. Provide a three-inch layer of mulch out to the drip line of each live oak tree.
- 4. Remove dead wood and stubs from each live oak tree.
- 5. Instruct the Parks and Recreation Department staff to avoid grass mowing in areas with exposed roots.

BE IT FURTHER RESOLVED:

The City Manager shall bring a proposal for a long-term solution to the City Council. The proposal shall include long-term options for raising the transmission lines, so that significantly less pruning is performed in future years on these live oaks. Firm and independent cost estimates are needed before alternative funding options can be explored. At a minimum, detailed cost assessments that also take into account changes in maintenance pruning methods and costs, shall include the following two scenarios:

- 1. Replace the two existing lattice structures on either side of Swearingen Drive with taller transmission support structures for the 138 kV transmission lines. This assessment shall include itemized costs, along with relevant logistical information such as the additional line clearance that would be achieved and the amount of lead time required once authorization is given.
- 2. Leave the two existing lattice structures in place, but add a third taller structure in between. This will likely be a lower-cost option. As with the first scenario, the assessment for this option should include detailed itemized costs, the additional line clearance obtained, and the necessary lead time for construction completion.
