## Subject

Authorize award and execution of a 36-month requirements supply contract with SAFEWARE INC., dba AIR INSTRUMENTATION, to provide hazmat personal protective equipment (PPE) for the Austin Fire Department (AFD) in an estimated amount not to exceed \$112,875, with three 12-month extension options in an estimated amount not to exceed \$37,625 per extension option, for a total estimated contract amount not to exceed \$225,750.

## Amount and Source of Funding

Funding in the amount of \$18,812 is available in the Fiscal Year 2012-2013 Operating Budget of the Austin Fire Department. Funding for the remaining 30 months of the original contract period and extension options is contingent upon available funding in future budgets.

This contract will provide the necessary equipment for the AFD to respond to various types of events involving hazardous materials including level "A" suits, gloves, boots, and gear bags.

AFD currently has three hazardous material teams that respond to these types of incidents. This equipment is critical in keeping firefighters safe and will meet or exceed the specifications defined in the 2007 edition of the National Fire Protection Agency (NFPA) 1994 Standard: Chemical, Biological, Radioactive, and Nuclear ensembles.
